The Prosecuting Attorney of the County of Jasper, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 565.072, RSMo, committed the class A felony of domestic assault in the first degree, punishable upon conviction under Section 558.011, RSMo, in that on or about August 1, 2020, in the County of Jasper, State of Missouri, the defendant knowingly caused serious physical injury to by shooting and and defendant were family or household members in that was the spouse of the defendant.

Count IV

The Prosecuting Attorney of the County of Jasper, State of Missouri, upon information and belief, charges that the defendant, in violation of Section 571.015, RSMo, committed the felony of armed criminal action, punishable upon conviction under Section 571.015.1, RSMo, in that on or about on or about August 1, 2020, in the County of Jasper, State of Missouri, the defendant committed the felony of Domestic Assault charged in Count III, all allegations of which are incorporated herein by reference, and the defendant committed the foregoing felony of Domestic Assault by, with and through, the knowing use, assistance and aid of a deadly weapon.
